# City of Snoqualmie Proposition No. 2



## BALLOT TITLE

PROPOSITION NO. 2

### COMMUNITY CENTER CONSTRUCTION

#### GENERAL OBLIGATION BONDS - \$9,000,000

The City Council of the City of Snoqualmie, Washington, passed Ordinance No. 910 concerning a proposition to finance the design, construction and equipping of a new community center. If approved, this proposition would authorize the City to design, construct and equip a new community center and related facilities on city owned property north of Ridge Street adjacent to Meadow Park, and carry out other capital purposes; issue up to \$9,000,000 general obligation bonds maturing within 20 years or less; and levy annual excess property taxes to pay and retire the bonds, all as provided in Ordinance No. 910. Should this proposition be:

## Explanatory Statement

If approved, this proposition would authorize the City of Snoqualmie to issue no more than \$9,000,000 of general obligation bonds to pay costs of designing, constructing and equipping a community center and related facilities to be located on City owned property north of Ridge Street adjacent to Meadow Park, and carrying out other capital purposes, as provided in Ordinance No. 910.

The City Council has found that there is an urgent need for a new community center and related facilities to better serve the City and its residents.

Without voter approval, there would be no funds to pay for the designing, construction and equipping of a new community center and related facilities.

The bonds would mature within 20 years, and be paid by annual property tax levies made in excess of regular property tax levies throughout the City at an estimated average of \$0.76 per \$1,000 of assessed value, or an estimated \$190 annually for a home valued at \$250,000.

Exemptions from taxes for the bonds may be available to homeowners who are 61 years of age or older, or disabled, and who meet income requirements set by state law.

## Statement for

Snoqualmie stands at the threshold of one of the most defining moments in its 100-year history. Our population is currently growing by over 600 residents per year and our Assessed Valuation is increasing by over \$100 million annually. This dramatic change has challenged us to redefine ourselves by blending the strengths and character of our past with a well-planned and bright future. This Community Center will be a profound symbol of Snoqualmie's endurance, tenacity and success during the past 100 years, and of our commitment to provide strong healthy recreational and social opportunities for our children. It will serve as a place to bind old and new together, as the Community Hall did years ago. The Center will be our common living room, hearth, and swimming hole; a warm refuge from dreary windy winters; a cool escape from hot and dry summers, and a second home during devastating floods. When the doors of the proposed Community Center and Pool open in the fall of 2005, our population will be over 6,000. We cannot depend on the county to provide these services for our community any longer. Let's start now. Please vote YES for our families, our children and our future.

## Rebuttal of statement against

Bond rates are decreasing and the tax revenue base is increasing. This combination will continue to reduce costs for everyone. The possible operating cost shortfalls are first year, worst-case scenarios excluding revenue from partnerships, school teams and other leagues.

## Statement against

Now is not the time to approve the \$9M Community Center bond. The financial information provided is inaccurate and will cost more than anticipated.

The \$28 membership fee is speculative. Fees will be set by City Council and estimated to be \$60-\$100/month per family.

The donation campaign raised only 1/10 of the money promised, requiring a \$1.5M bond measure increase. Most major Corporations and potential public and private users were unwilling to obligate themselves.

The addition of a pool to the basic community center provides insufficient parking. The pool facility is inadequate for swim meets, limiting our revenue potential. There is no room for future growth.

Maintenance and Operations (M&O) costs are estimated at an extremely low \$770,218, based on a 1999 study of much smaller facilities. Projected revenue of \$425K leaves a minimum deficit of \$345K. M&O costs increase 1-6% yearly. The City can cover deficits by cutting services, raising taxes and adding population/development. The plan to cover this deficit is a yearly levy set at \$.11/1000.

Snoqualmie voters must consider the financial burden this bond will put upon the City's budget and citizens for many years. We can't afford it.

Vote NO on the Community Center bond.

## Rebuttal of statement for

A Community Center would certainly be a wonderful amenity for our community. Unfortunately the Center we are voting on is way beyond our means, and much too speculative. Snoqualmie's Comprehensive Plan identifies 10,000 as the population needed for an affordable Community Center. An enhanced design better suited to ensure success, is essential. Let's not leave our families, our children, our future and our city struggling to find ways to pay these debts.

# Fire Protection District No. 50 Proposition No. 1

## BALLOT TITLE

### PROPOSITION NO. 1

#### RENEWAL OF EXISTING PROPERTY TAX LEVY FOR FIRE AND LIFE SAFETY SERVICES

Shall King County Fire Protection District No. 50 be authorized to levy a regular property tax of One Dollar and 50/100 (\$1.50) per One Thousand Dollars (\$1,000.00) of true and fair valuation, to be levied in 2002 for collection in 2003? This shall not be construed to authorize an excess levy and shall be subject to otherwise applicable statutory dollar rate limitations. Should this proposition be approved?

## Explanatory Statement

In 2002 the District levied \$172,070.00 in property taxes. \$102,070.00 came from the District's regular levy and \$70,000.00 was levied by special authority granted to the District for payment of Bond Debt. The District's levy rate for regular taxes was \$1.22 per thousand dollars of assessed valuation or approximately \$244.00 per year in taxes for a home valued at \$200,000.00. Presently however that home also pays for bond debt retirement at a rate of approximately \$0.85 per thousand of assessed valuation, or approximately \$170.00 per year. Thus, for the year 2002 a theoretical home valued at \$200,000.00 in the District pays approximately \$414.00 per year for fire protection and bond retirement.

Assuming that the District with voter approval increased the regular property tax rate to the statutory maximum of \$1.50 per thousand of assessed valuation a \$200,000.00 home would pay \$300.00 per year for fire district taxes, assuming that all bond debt were retired. This would result in an increase in regular property taxes for the homeowner of slightly over \$50.00 per year, but an overall decrease in total fire district property taxes of over \$100.00 per year.

## Statement for

The members of the Skykomish Volunteer Fire Department are proud of the accomplishment that district has made in the past few years. Some of the progress that has been made resulted from the special bond levy that will be paid off December 2002. This special request to lift the 1.06% statutory property tax limit and the authority to levy the \$1.50 per thousand fire and EMS levy for collection in 2003, will allow the district to continue to provide the same high level service that the residents have enjoyed in the past. When approved, the 2003 tax levy will be less than the current taxes being collected.

The district is currently working to provide an intermediate level of medical service. This will increase the types of medical assistance that can be provided by our EMT's. This level of medical service will require additional training and equipment. Passage of this special levy will be needed to fund progress.

# Public Hospital District No. 4 Proposition No. 1



## BALLOT TITLE

### PROPOSITION NO. 1 PROPERTY TAX LEVY FOR ESSENTIAL HEALTH SERVICES

The Commissioners of Public Hospital District No. 4 adopted Resolution No. 252-0820 concerning a proposition to increase its regular property tax levy. If approved, this proposition would authorize the District to increase its regular property tax levy rate from its current level to a rate of 50 cents per \$1,000 of assessed value for collection in 2003, which amount will be used for computing legal limits on levies in subsequent years, to provide funding for essential health care services for the benefit of District residents. ## Explanatory Statement

If approved, this property tax levy would permit King County Public Hospital District No. 4, which owns and operates Snoqualmie Valley Hospital, to fund the operation of a new 24-hour Urgent Care Health Clinic at the hospital. The new clinic will be owned and operated by the public hospital district.

The district's board of commissioners has found that there is a demonstrated need for local, around the clock, urgent care medical services to better serve the needs of the residents of the public hospital district. As such, the district would like to provide a district operated 24-hour clinic as the first step in bringing Level 5 Trauma Services to the Valley.

Without voter approval, there would be insufficient funding to pay for equipping, staffing and operating these services on a 24-hour basis.

The levy increase of approximately \$.07 per thousand of assessed value, or an estimated \$17 annually for an average value house in the district, would return the district's regular property tax rate to the 1996 level.

All district homeowners are entitled to a \$100 annual discount on inpatient services provided by Snoqualmie Valley Hospital upon presentation of proof of tax payment for the current tax year.

## Statement for

Having 24-hour access to urgent care is something drastically needed in the Valley. We haven't had local access to 24-hour care since 1997, and a lot has happened, both locally and nationally since that time.

A new 24-hour urgent care clinic, as the first step toward receiving a Level 5 Trauma Service designation for the hospital, would help local medical services keep pace with community growth and need. In the aftermath of the 2001 earthquake, September 11 incident, I-90 tanker fire in Issaquah and on-going national concerns regarding chemical and biological terrorism, the community needs around the clock access to Urgent Medical Services and Providers.

By voting YES on this levy proposition, Valley residents will have 24-hour access to medical providers for themselves, their families and to support the local EMS system.

This proposition is supported by: Snoqualmie Tribe and Overlake Hospital Medical Center.

## Statement against

This levy proposition is just another tax increase masquerading as needed services.

We currently have a great EMS system in place and there is already one 10-hour/day private urgent care clinic in the Valley. Geographically, other hospitals and clinics are reasonably close to populated areas of the district and many residents of the district don't even know that the hospital re-opened almost 2 years ago. Why do they want to add services now?

The Committee Advocating Rejection encourages a NO vote.
