Notes: Notes:

- There was one voter who voted both at an AVC and by mail. The AVC ballot was issued in error after the mail ballot had been accepted and opened. Although the ballot accountability for both mail and AVC ballots reconciles, our registration system does not allow for both ballots to appear and be accounted for at the same time. In this case, this final report reflects actual ballots counted.
