REVISED REPORT AND RECOMMENDATION TO THE KING COUNTY COUNCIL.

SUBJECT: Department of Transportation File No. **V-2173**, Proposed Ordinance No. **95-611**

PRELIMINARY REPORT:

The Department of Transportation's Preliminary Report on Item No. V-2173 was received by the Examiner on October 11, 1995.

PUBLIC HEARING:

After reviewing the Department's Report and examining available information on file with the application, the Examiner conducted a public hearing on the subject as follows:

The hearing on Item No. V-2173 was opened by the Examiner at 9:21 a.m., October 4, 1995, in Room No. 2866, Jackson Federal Building, 915 Second Avenue, Seattle, Washington, and adjourned at 9:42 a.m.

The hearing was continued for administrative purposes for not longer than six months to enable petitioners to submit one or more appraisals of the property to be vacated. On April 11, 1996, the Hearing Examiner received a memorandum from the Road Services Division that petitioners Elliott and Dallosto had withdrawn their request for vacation. On April 24, 1996, the petitioner Witt advised the Hearing Examiner that he had decided not to submit any appraisals and agrees to the assessed value set by the County for the property to be vacated adjacent to Lot 12. On May 1, 1996, the Hearing Examiner declared the public hearing to be closed, and on May 9, 1996, a Report and Recommendation to the King County Council was issued.

Following issuance of the May 9 Report, the Hearing Examiner was advised by Petitioner Witt and the Road Services Division of errors contained therein. On May 29, 1996, the hearing record was re-opened for administrative purposes, and on June 14, 1996, the record was closed. Participants at the public hearing and the exhibits offered and entered are listed in the attached minutes. A verbatim recording of the hearing is available in the Office of the King County Hearing Examiner.

FINDINGS, CONCLUSIONS & RECOMMENDATION: Having reviewed the record in this matter, the Examiner now makes and enters the following:

FINDINGS:

1. General Information:
Road name and location: Portion of 106th Avenue SE, north of SE 188th Court if extended
Right of way classification: C

Area: 718 square feet
 Compensation: \$2,444.79

2. Except as provided below, the Examiner adopts and incorporates herein by this reference the facts set forth in the Department of Transportation's Report to the King County Hearing Examiner for the October 4, 1995, public hearing and the statement of facts contained in Proposed Ordinance No. 95-611, June 27, 1996 draft. The said report and proposed ordinance will be attached to the copies of this report and recommendation submitted to the King County Council.
3. Petitioners Thomas, Elliott and Dallosto have withdrawn from this proceeding. Petitioner Witt has deposited with King County funds required for payment of compensation for the 10 feet of right-of-way adjacent to Lot 12 of the Plat of Cougar Meadows. The remaining 40 feet of right-of-way for 106th Avenue SE, lying between Lot 12 of Cougar Meadows and Lot 7 of Panther Lake Garden Tracts, will not be affected by this vacation.
3. Maps showing the vicinity of the proposed vacation and the specific area to be vacated are Attachments 1 and 2 to this Report and Recommendation.

CONCLUSIONS:

1. The westerly ten feet of the road adjacent to the east of Lot 12 of the plat of Cougar Meadows is useless as part of the King County road system, and the public will be benefited by its vacation.
2. The Notice of Hearing on the report of the Department of Transportation was given as required by law, and a hearing on the report was conducted by the King County Hearing Examiner on behalf of the King County Council.
3. The compensation required by law to be paid as a condition precedent to the vacation of the westerly ten feet of this road adjacent to Lot 12 of the plat of Cougar Meadows has been deposited with King County, and the easements, if any, necessary for the construction, repair and maintenance of public utilities and services have been provided in form satisfactory to the affected public utilities.

RECOMMENDATION:

APPROVE proposed Substitute Ordinance No. 95-611, June 27, 1996 draft, to vacate the right-of-way described as:

The westerly 10 feet of 106th Avenue Southeast dedicated in the plat of Cougar Meadows, Volume 161, pages 47-51, records of King County, lying easterly of Lot 12 of said plat.

NOTICE OF RIGHT TO APPEAL
 AND ADDITIONAL ACTION REQUIRED

In order to appeal the recommendation of the Examiner, written notice of appeal must be filed with the Clerk of the King County Council with a fee of \$125.00 (check payable to King County Office of Finance) on or before July 12, 1996. If a notice of appeal is filed, the original and 6 copies of a written appeal statement specifying the basis for the appeal and argument in support of the appeal must be filed with the Clerk of the King County Council on or before July 19, 1996. Appeal statements may refer only to facts contained in the hearing record; new facts may not be presented on appeal.

Filing requires actual delivery to the Office of the Clerk of the Council, Room 403, King County Courthouse, prior to the close of business (4:30 p.m.) on the date due. Prior mailing is not sufficient if actual receipt by the Clerk does not occur within the applicable time period. The Examiner does not have authority to extend the time period unless the Office of the Clerk is not open on the specified closing date, in which event delivery prior to the close of business on the next business day is sufficient to meet the filing requirement.

If a written notice of appeal and filing fee are not filed within 14 days calendar days of the date of this report, or if a written appeal statement and argument are not filed within 21 calendar days of the date of this report, the Clerk of the Council shall place a proposed ordinance which implements the Examiner's recommended action on the agenda of the next available Council meeting. At that meeting, the Council may adopt the Examiner's recommendation, may defer action, may refer the matter to a Council committee, or may remand to the Examiner for further hearing or further consideration.

Action of the Council Final. The action of the Council approving or adopting a recommendation of the Examiner shall be final and conclusive unless within twenty (20) days from the date of the action an aggrieved party or person applies for a writ of certiorari from the Superior Court in and for the County of King, State of Washington, for the purpose of review of the action taken.
