70% Recycling Rates	Discuss strategies for achieving a 70% recycling rate.
Election of Chair and Vice Chair	<p>In accordance with MSWMAC's adopted bylaws, the chair and vice chair are elected every February for a 1 year term. Sustainable Solid Waste Management Study	<p>The Sustainable Solid Waste Management Study evaluated options in five areas:</p> <ol style="list-style-type: none"> 1. resource recovery at division facilities; 2. construction and demolition debris; 3. organics processing; 4. disposal alternatives and technologies; and 5. sustainable system financing: Scope in March <p>The division will be scoping three projects as a result of this study:</p> <ul style="list-style-type: none"> • Feasibility assessment of anaerobic digestion at division facilities • Solicitation of proposals to explore the private industry's interest and ideas for managing a portion of the waste stream using alternative technologies • Assessment of possible new fee structure which would consider what services would be funded by the new fee, how the fee would be structured and how the fee would be collected and how it would affect the tip fees <p>Schedule:</p> <ul style="list-style-type: none"> • TBD
Transfer Plan Report 2	<p>A draft report on identification and analysis of demand management strategies that could be implemented in lieu of siting and building a new recycling and transfer station in northeast King County is due to council March 2015 and a final report is due June 2015.</p> <p>Schedule:</p> <ul style="list-style-type: none"> • April: Discuss draft report • August: Action on Final report
Comprehensive Solid Waste Management Plan	<p>Presentation and discussion of potential updates to the Draft 2013 Comp Plan</p> <p>Schedule:</p> <ul style="list-style-type: none"> • Jan – August: Presentations and discussions
Construction and Demolition Debris	<p>The division is preparing to implement new rules governing C&D management in King County. In order to manage comingled (mixed) C&D generated in King County, recycling facilities must enter an agreement with the division and adhere to disposal bans on readily recyclable materials. For this program to be fully successful, the division will be working with cities via the Green Building Program's regional code collaboration to support cities efforts in implementing complementary C&D recycling requirements via their building permit departments.</p> <p>Schedule: Jan and Feb: Project status updates will be provided</p>
Product Families	<p>Updates on the division's progress in development of the Waste Prevention, Resource Recovery, and Disposal product families</p> <p>Schedule:</p> <ul style="list-style-type: none"> • February, May, August and November: Updates on the identification of strategies for achieving waste prevention, resource recovery and

Interlocal Agreements	Review and status update of parties responsibilities under both the original Interlocal Agreements and the Amended and Restated Interlocal Agreements.
