Wtrbdy.shp is a GIS file used by King County containing information compiled from a variety of sources, some unidentified in the metadata. Wolcott, 1965 is the source from which WAC 173-20-360 was originally compiled. Ecology provided the data in column 3. Column 4 contains values derived by redrawing boundaries as described in section 1. Lakes on Federal lands are being included in the program for the first time.
