#### PUBLIC HOSPITAL DISTRICT NO. 1 KING COUNTY PROPOSITION NO. 1

#### VALLEY MEDICAL CENTER EMERGENCY MEDICAL AND HOSPITAL SERVICES LEVY

The Commission of Public Hospital District No. 1 adopted Resolution No. 807 proposing to increase its levy for emergency medical care and other services. If approved, the District's regular property tax levy would increase in 2005 to 59 cents per \$1,000 of assessed value to support (i) emergency medical care at Valley Medical Center; (ii) emergency room doctors and nurses including an emergency room triage nurse available 24 hours a day; (iii) firefighters who serve as emergency medical technicians in Southeast King County; and (iv) other hospital services. Increases in the District's levy after 2005 will be subject to chapter 84.55 RCW. Should this proposition be:

為緊急醫療及醫院服務徵稅

第1號公立醫院區委員會，為緊急醫療及其它服務增徵物業稅而採納了第807號決議案。如此提案受通過，在2005年，區內的常規物業稅將增至每一千元估值價，徵收五角九仙稅款以支持 (i) Valley 醫療中心的緊急醫療服務；(ii) 急症室醫生，護士，包括一名二十四小時長駐急症室負責分配的急症診斷專責護士；(iii) 能充當景郡東南區緊急醫療技術員的消防員；及(iv) 其它醫院醫療護理服務。2005年後，區內的物業稅增收率則需按華盛頓州修訂法第84.55章之規定。此提案應否被通過：
